

**ORDINANCE NO. 114**

**AN ORDINANCE TO PROVIDE FOR THE RATE TO BE CHARGED FOR SOLID WASTE SERVICES FURNISHED TO CUSTOMERS OF THE VILLAGE OF CHOUDRANT; TO PROVIDE FOR THE EFFECTIVE DATE THEREOF; AND OTHERWISE TO PROVIDE WITH RESPECT THERETO.**

**NOW, THEREFORE, BE IT ORDAINED**, by the Board of Aldermen of the Village of Choudrant, Louisiana, convened in Regular Session this 13th day of September, 2010, that the following Ordinance is hereby enacted:

**SECTION 1.**

All solid waste customers of the Village of Choudrant shall be charged and billed for curbside or container site pickup, weekly or bi-weekly, at the following rates:

Household Can	\$ 6.00
4 Yard Commercial-1/week	\$30.00
4 Yard Commercial-2/week	\$45.00
6 Yard Commercial-1/week	\$45.00
6 Yard Commercial-2/week	\$67.50
8 Yard Commercial-2/week	\$90.00

**SECTION 2.**

All solid waste customers will be billed in conjunction with the water and wastewater billing system and are subject to the same late penalties that apply to all water customers, and that failure to pay will subject the customer to discontinuation of all municipal provided utility services.

**SECTION 3.**

If any section, paragraph, sentence, clause and/or phrase of this Ordinance or the application thereof is declared unconstitutional, unenforceable or invalid by the valid judgment of any court of competent jurisdiction such unconstitutionality, unenforceability or invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses and/or phrases of this Ordinance, since the same would have been enacted by the Village of Choudrant without the incorporation in this Ordinance of any such unconstitutional, unenforceable or invalid section, paragraph, sentence, clause or phrase. To that end, the provisions of this Ordinance are hereby declared severable.

**SECTION 4.**

All other ordinances, or any parts thereof, which are in conflict with the provisions of this Ordinance are hereby repealed.

**SECTION 5.**

This Ordinance shall become effective October 1, 2010.

The above and foregoing Ordinance was introduced on August 2, 2010, at a regular meeting of the Board of Aldermen of the Village of Choudrant, Louisiana, a public hearing having thereafter been held, title having been read, and a motion to adopt said ordinance was made by Alderman Aswell. The motion was seconded by Alderwoman Morrison, and after having been considered by title was adopted as a whole by the following YEA and NAY vote:
